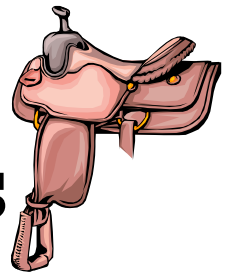

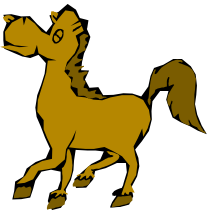

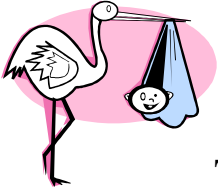
Royalty Report
