## Fall Gymkhana Series

Please Note Date and Time Change!

The Windy Mountain Ranchers and Knot-N-Trot 4-H Clubs in partnership with Cheyenne Saddle Tramps is having a Fall Gymkhana series at the LCCC indoor arena. Each event will run on Sunday mornings 7:30am-11:00am except the final which will run Saturday December 17th 12:00-5:00. **The Sunday events will end promptly at 11:00am!** Check in will begin at 7:00. All Gymkhanas will be payback with high point awards for the series possible depending on participation. **Dates: November 13, and 20, December 4 and the final is Saturday December 17th** with additional details TBA. December 18 is a potential snow/rain date. Classes: lead line, walk/trot, Jr. (10 and under), Int. (11-13) Sr. (14-18), Adult (19 and over) all ages determined as of January 1, 2011.

Cost will be \$5.00 per class with a \$10.00 office fee charged per horse. All proceeds will go toward arena fees and for the 2012 Laramie County Horse Show awards. We will run barrels, poles, speed barrels, and a potential fourth race TBA.
