In addition to assuming all inherent risks as states above, the Participant hereby agrees that he/she shall irrevocably and forever release and discharge the Cheyenne Saddle Tramps, it's officers, directors and members (hereinafter collectively known as "Released Parties") from any and all liability of any kind whatsoever, including without limitation, any damages resulting from the Released Parties' acts of negligence, and from all legal claims or legal liability of any kind, nature and description, present or future, involving or relating to property damage, bodily injury or death suffered or sustained as a result of engaging in or any way arising out of participation in this event.

Participant agrees to defend, at his/her own expense, and to indemnify and hold harmless the Released Parties from any and all claims and demands brought against them or their participants related in any way to or arising out of the participation in this event including actions based on the negligence of the Released Parties or Participants, including all costs and attorneys fees incurred by the Released Parties in enforcing this general release.
